Definitions

2. **Albert Park** means the "declared area" and "designated access area" as those expressions are defined in the Act
3. **NOTAM** means Notice to Airmen
4. **Operator** means the helicopter operator entity detailed above
5. **Organisers means:**

 - the Crown in right of the State of Victoria;
 - the Minister administering the *Australian Grands Prix Act 1994 (Vic)*;
 - the Minister administering the *Crown Land (Reserves) Act (Vic)*;
 - Parks Victoria;

 - APP Corporation Pty Limited (ACN 003 764 770);
 - Federation Internationale de l'Automobile;
 - Formula One World Championship Limited;
 - Formula One Hospitality and Event Services Limited (UK),

 - Formula One Asset Management Limited;
 - Confederation of Australian Motor Sport Ltd (ACN 069 045 665);

 - all other persons involved in the conduct, promotion and organisation of the Event including officials, marshals, rescue and medical staff, the competitors and drivers; such parties to

include where relevant all directors, officers, employees, agents, contractors and affiliated companies and their respective personnel

Payment

6. The Operator agrees to accept liability for payment of all landing fees at the rates set out above.

NOTAM

7. The Operator acknowledges receipt of the NOTAM and operational procedures for helicopter flights to and from the Formula One event (as defined in the Act) known as the 2017 FORMULA 1® ROLEX AUSTRALIAN GRAND PRIX to be held at Albert Park (**Event**).
8. The Operator must ensure that all pilots operating the helicopters registered above are properly briefed, agree to and will comply with the NOTAM and operational procedures for all helicopter flights to and from Albert Park.

Relocation of helicopter

9. The Operator hereby authorises the Organisers or any of them to relocate, or procure the relocation of, any of the above mentioned helicopters or any other equipment belonging to the Operator at any time if, in the opinion of the Organisers, the helicopter or equipment is interfering with the conduct of any part of the Event.

Insurance

10. The Operator agrees to take out the insurance detailed in the attached Insurance Declaration Form and will ensure that its insurance company, agent or broker provides a completed form to Mr Ben Hall, Professional Helicopter Services Pty. Ltd., Bundora Parade, Moorabbin Airport (Fax: 03 9587 3821 email: operations@phs.com.au) by 17 March 2017.

Release and indemnity

11. The Operator acknowledges and accepts that motor racing and related activities are dangerous and accidents can happen, and that entry to and remaining at the Event has a degree of danger.
12. To the extent permitted by law, the Operator and each of its pilots, employees, agents, sub-contractors, consultants (including employees of those agents, sub-contractors and consultants), directors, officers and sub-licensees (and anyone acting on behalf of or at any of their direction) (**Personnel**) excludes, releases and forever discharges each of the Organisers from all liability for claims, loss, damage, costs or expenses (whether arising under statute, from negligence, personal injury, death, property damage, infringement of third party rights or otherwise) arising from or in connection with the Event or the helicopter operations.
13. The Operator acknowledges and agrees that none of the Organisers will be responsible for acts, omissions or defaults of the Operator or its Personnel nor, to the extent permitted by law, will any Organiser be liable for any claim, loss, damage, cost or expense (whether arising under statute, from negligence, personal injury, death, property damage or infringement of third party rights or otherwise) arising from any act, matter or thing done, or permitted or omitted to be done, by the Operator or its Personnel pursuant to or in connection with the Event or the helicopter operations.
14. The Operator indemnifies and must keep indemnified each of the Organisers and their respective Personnel against all such claims, loss, liability, damage, cost or expense which may be incurred or sustained by any of the Organisers or their Personnel arising from any act, matter or thing done, permitted or omitted to be done by the Operator or its Personnel pursuant to, in default of or in connection with the Event or the helicopter operations.

In order for you to register to land your helicopter within Albert Park (being the "declared area" and "designated access area" as those expressions are defined in the *Australian Grands Prix Act 1994 (Vic)*) at the 2017 FORMULA 1® ROLEX AUSTRALIAN GRAND PRIX, you must arrange an aviation hull and liability policy that incorporates public liability (including personal injury and death and passenger liability and flight, taxiing and ground aviation risks) and property damage (including your own and any third party property). The public liability and aviation cover must be for a minimum of \$20 million (for each occurrence) and property damage cover must be for full replacement value. The policies must contain a cross liability clause and name the Operator and each of the parties below as joint insureds. The Operator will be liable for all premiums and excesses payable in relation to any insurance cover affected and shall further be responsible for any loss, damage, injury or other occurrence which falls outside the scope of the cover provided by the policies.
