<b>Item 13: Restriction to Entry</b>	<p>Entrants must be GP Advantage member or Corporate Hospitality patron for the Formula 1® Australian Grand Prix 2019.</p> <p>Entry is only open to Victorian residents aged 18 years and over. The Promoter, Ticketmaster Australasia Pty Ltd (<b><i>Ticketmaster</i></b>), licensees, on-sellers and their employees (and their immediate families), and their agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1<sup>st</sup> cousin.</p>

The Associated Entities will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence) by any person in connection with this promotion or accepting or using a prize, except for any liability which cannot be excluded by law (in which case that liability is limited to the minimum allowable by law).
